Minutes of the meeting of the Procurement Committee held on 25th January 2019 at 2.00 PM for evaluation of bids for the project entitled "Development of Sindh Madressatul Islam University (SMIU) Campus at Education City Malir, Karachi (Lot #1, Faculty Blocks 2 Nos.)"

The meeting started with the name of AL MIGHTY ALLAH, after then the Project Coordinator (Malir Campus) briefed the committee about the tender for "Development of Sindh Madressatul Islam University (SMIU) Campus at Education City Malir, Karachi (Lot #1, Faculty Blocks 2 Nos.)" which was opened on 18th January 2019 before Procurement Committee constituted vide notification No. SMIU/NOT/2018/256 dated: 31-12-2018 and representatives of participating bidders. Out of 18 bidders to whom the tender documents were issued, only five (05) bidders returned their filled/sealed tender documents.

The bid amount offered by participation bidders at the time of opening of bid is mentioned below:

1. Noorulhaq & Brothers Construction Company	Rs. 410,410,594/-
2. NLC Engineers	Rs. 509,773,840/-
3. Kashif Constructor's	Rs. 432,778,985/-
4. Sherjan Mosakhail & Sons	Rs. 417,016,373/-
5. Canny Engineers & Developers	Rs. 397,340,484/-

The tender documents were sent to M/s. EA Consulting (Pvt.) Ltd. vide this office letter No. SMIU/W&S/2019/23 dated 21-01-2019 being the consultant of the project for evaluation report.





M/s. EA Consulting (Pvt.) Ltd. sent the bid evaluation report vide letter No. EA/986/0172/2019 dated 25-01-2019. As per evaluation of consultant the corrected final quoted amount of M/s Canny Engineers & Developers is Rs. 397,005,958/- which is 11.87% below the Engineer's estimated amount of Rs. 450,495,566/-

Moreover, EA Consulting Pvt. Ltd. recommended that the work may be awarded to M/s Canny Engineers & Developers being 1st Lowest bidder at the corrected bid amount Rs. 397,005,958/-

Recommendations of procurement committee are as under

After detail deliberations/discussion the procurement committee unanimously recommended that the work "Development of Sindh Madressatul Islam University (SMIU) Campus at Education City Malir, Karachi (Lot #1, Faculty Blocks 2 Nos.)" may be awarded to M/s Canny Engineers & Developers for amounting to Rs. 397,005,958/- which is 11.87% below the Engineer's estimate of Rs.450495566/- being the 1st lowest bidder.
