Minutes of the meeting of the Procurement Committee held on 14th September 2018 for Evaluation of Bids for "Development of SMIU Model School and University Academic Blocks at SMIU, City Campus, Karachi (Phase-2: Academic/IT Block)"

The tender for "Development of SMIU Model School and University Academic Blocks at SMIU, City Campus, Karachi (Phase-2: Academic/IT Block)" was opened on 29th August 2018 in front of Procurement Committee constituted vide notification No. SMIU/NOT/2018/087 dated 23-5-2018 and representatives of participating Contractor. Out of 03 Contractors to whom the Tender Documents were issued all 03 Contractors returned the filled tender documents, as mentioned below:

The tender documents were sent to M/s. EA Consulting (Pvt.) Ltd. vide letter No. SMIU/P&D/2018-1176 dated 30th August 2018 being the consultant of the project for evaluation and recommendation. M/s. EA Consulting (Pvt.) Ltd sent the bid evaluation report vide letter No. EA/986/2073/2018 dated 13th September 2018.

As per evaluation of consultant, the corrected final quoted amount of **M/s. Canny Engineers and Developers** is **Rs. 153,009,848.48** which is 14.58% below the Engineer's Estimated amount of Rs. 179,121,733.48/-. However, the consultant pointed out in Conclusion para 6(a) that M/s. Canny Engineers and Developers have quoted unrealistically low rates in items as mentioned in para 5.2.3.a of report and recommended that SMIU obtain 10% performance bank guarantee and undertaking to counter para 5.2.3a (to execute all these items of works as mentioned in BOQ) prior to award of work. Accordingly, M/s. Canny Engineers and Developers has provided undertaking on stamp paper reaffirming to execute all the items as per their quoted rates and have agreed to submit 10% performance bank guarantee as well.


M/s. Kashif Constructors made a complaint through their letter against the lowest bidder M/s. Canny Engineers and Developers for non-submission of documents, however their complaint is deemed unreasonable by Procurement Committee as M/s. Canny Engineers and Developers submitted these documents on the same day. However, complaint of M/s. Kashif Constructors is being looked upon by Complaint Redressal Committee.

RECOMMENDATIONS OF PROCUREMENT COMMITTEE ARE AS UNDER: -

After detailed discussions and evaluation the Procurement Committee unanimously recommended to award the work for "Development of SMIU Model School and University Academic Blocks at SMIU, City Campus, Karachi (Phase-2: Academic/IT Block)" to M/s. Canny Engineers and Developers for the amount of **Rs.153,009,848.48** which is 14.58% below the Engineer's Estimated amount of Rs. 179,121,733.48/- subject to providing 10% performance bank guarantee.


