Minutes of the meeting of the IT Procurement Committee regarding Technical Evaluation

The IT Procurement committee meeting for opening of technical proposals for tender titled Procurement of 100 Branded Desktop Computers for Labs and Faculty at SMIU, Karachi was held on 19th January 2024 at Conference Room No. 2 at First Floor main building Sindh Madressatul Islam University, Karachi.

The meeting started with the name of Almighty ALLAH, then the sealed Technical Proposals of seven (07) participating companies were opened under SPPRA Rule 46 (2) single stage two envelope procedures in the presence of IT Procurement committee & bidders/authorized representatives.

The IT Procurement Committee further conducted several meetings and evaluated the technical proposals as per eligibility criteria mentioned in the bidding documents. As the minimum criteria for evaluation of Technical proposals was 80%. After detailed scrutiny, M/s. Commtel, and M/s. Texitech offered Lenovo Think Center Neo 50t, whereas M/s. AJ Enterprises Offered HP Pro 280 G9. M/s. Commtel confirmed via email that this computer don not support Wifi 6E whereas M/s. Texitech stated that they will provided wifi 6E with this system. The technical members of the committee (IT Department/related Faculty) ascertained that the Lenovo Neo 50t cannot support wifi 6E as per our BOQ hence both the parties were technically disqualified. Furthermore, HP website also shows that HP Pro 280 G9 also doesn't support wifi 6E therefore all three parties where technically disqualified by the technical members of the committee.

Additionally, M/s. Mega Plus was initially disqualified based on their blacklisting by PPRA and FBR. However, M/s. Mega Plus presented legal documents that their blacklisting was initiated on 6th February 2024 and was overturned by the court of law on 15th February 2024 which is also mentioned on PPRA website. Hence, their disqualification was overturned in light of presented evidences.

Hence, mentioned below four (04) companies were technically qualified by IT Procurement Committee and recommended for opening of the Financial Proposals of all four (04) qualified companies. Detail is as under:
