- 3 The filled Sealed Offers/Bids will be received back on Friday 11th October 2019 by 15:00 hours and will be opened on same day at 15:30 hours at **Sindh Madressatul Islam University, Aiwan-e- Tijarat Road Behind Habib Bank Plaza, Karachi** before the Auction committee and the bidders or their authorized representatives who wish to be present.
- 4 The Vehicles can be inspected from Thursday 3rd October 2019 to Thursday 10th October 2019 during office hours at Sindh Madressatul Islam University, City Campus, Karachi.
- 5 Bids/Offeres should be accompanied by 25% offer price as earnest money in form of a pay order in favor of **"Sindh Madressatul Islam University"**. Earnest money of the successful bidder will be adjusted against the bid/offered price of the successful bidder. Whereas earnest money of unsuccessful bidders will be returned back to the parties.
- 6 Bids/offers submitted without earnest money will be not be accepted.
- 7 The highest bid above reserve price will be accepted and each Vehicle will be sold separately to the highest bidder of each respective vehicle.
