- 6. You are hereby advised to inspect the site immediately and take possession of the site and submit handing miling over proforma duly signed and stamped within three (03) days from the date of this letter. The firm of handing taking over proforma is enclosed.
- 7. The performance security submitted by you @ 10% of bid cost i.e. Rs. 15,300,985/- vide Bank Guarantee No. IGT00680269813PK shall be returned after satisfactory completion of defects liability period of 12 months.
- R. If you fail to complete the work within the stipulated time (i.e. 18 months), the day to day liquidated diamages at the rate of 0.075% of the value of contract per day shall be recovered from you subject to menimum of 10% of the value of contract.
- 9. The specified date of this letter shall be deemed as the start of this contract.
