- 3. You are advised to undertake work as per BOQ and specifications mentioned in tender documents submitted by you. It is understood by the both parties that this contract shall be governed by the following terms & conditions:
  - i. The rate quoted by you are inclusive of cost of all of items require for the subject work (all taxes, levies and duties (Federal, provincial and Local bodies) or any other incidental charges that may occur in carrying out the work).
  - The Performance Security submitted by you @ 5% of bid cost for amounting to Rs. 13, 100/- vide Pay Order No. 2903736 dated 10-01-2019 shall be returned after satisfactory completion of defects liability period of three (03) months.
  - iii. In the event of failure of work or un-satisfactory performance, *SMI University* shall have the right to terminate the contract and forfeit the Performance Bank Guarantee and any other amount due against the work done and work may be awarded to any other source/agency at your risk and cost.
  - iv. Any claim on account of escalation in contract price for any reason whatever during the executing of contract shall not be entertained / paid by SMI University.
  - y. You will not sublet the work in part or full in any case.
  - vi. If you fail to complete the work within the stipulated time (i.e. 30 days), the day to day liquidated damages at the rate of 1.33% of the value of contract per day shall be recovered from you subject to the maximum of 10% (ten percent) of the value of contract.
  - vii. The bill amount of vendor due for payment will be paid by SMI University within appropriate time.
  - viii. All defects will be rectified by the vendor at his own risk and cost before and during maintenance period.

- ix. Time is the essence of this Contract and please pay particular attention to expedite the completion of work within the contract period.
- The work shall be carried as per BOQ and under effective supervision of Project Coordinator Malir Campus, SMIU who shall ensure that material supplied/work carried out is satisfactory.
- xi. The duration of defect liability period maintenance period is three (03) months.
- Time of completion of this work shall be (30) Days reckoned from the date of commencement of Work Order issued by the Executive Engineer, SMIU.
